Pelo presente instrumento, de um lado, a **CÂMARA MUNICIPAL DA ESTÂNCIA TURÍSTICA DE IBITINGA**, entidade jurídica de Direito Público, inscrita no CNPJ nº. 72.918.782/0001-53, com sede na Cidade de Ibitinga, Estado de São Paulo, à Avenida Dr. Victor Maida, nº 563, representada neste ato por seu Presidente, Vereador o Senhor **ANTONIO ESMAEL ALVES DE MIRA**, brasileiro, casado, residente e domiciliado neste Município de Ibitinga na Rua Vereador José Castilho Marques nº. 856 – Jardim Eldorado, Ibitinga SP, portador do RG: 13.499.903-4 e do CPF: 020.526.358-58, doravante denominada simplesmente **CONTRATANTE**, e, de outro lado, a Empresa **F. MARTINS VIEIRA - EPP**, com sede na Praça Rotary Club, 305 –City Ribeirão, Ribeirão Preto SP, inscrita no CNPJ/MF sob nº. 05.624.716/0001/83, neste ato representada pelo seu Diretor o Senhor **DIMAS LONGHINI HERMINIO FAUSTO**, brasileiro, casado, com endereço à Rua Dr. Antônio Engracia de Oliveira, nº. 50, Bairro City Ribeirão, na cidade de Ribeirão Preto, Estado de São Paulo, portador do CPF nº: 131.105.968-73 e do RG:20.321.423 doravante denominada **CONTRATADA**, têm entre si, justo e acordado o presente Contrato de Locação e Suporte Técnico do Software Gerenciador de Ponto Saturno, resolvem **PRORROGAR E REAJUSTAR** o instrumento de Contrato retro mencionado, firmado entre as partes, conforme segue:

Fundamenta-se esta prorrogação nas Cláusulas 6ª do índice, onde será reajustado pelo IPCA (Índice Nacional de Preços ao Consumidor Amplo) índice de 4,8313% até janeiro de 2025 e Cláusula 7ª – da Vigência do Contrato nº. 207 de 07 de fevereiro de 2022 e no parecer do Procurador Jurídico do Poder Legislativo.
